SCHOOL OPERATIONS

Administrative Procedure #212 Controversial Issues

Background

Thrive Elementary School believes that in providing students with the opportunity to deal with controversial issues it can fulfill its commitment to students to provide relevant, challenging, life-based learning opportunities.

Definition

Controversial issues are those topics that are publicly sensitive and upon which there is no consensus of values or beliefs. They include topics on which reasonable people may sincerely disagree. The Alberta Human Rights Act identifies these issues as religion, religious themes, human sexuality and sexual orientation.

Procedures

Controversial issues that have been anticipated by the teacher and those that may arise incidentally during instruction, are to be used by the teacher to promote critical inquiry and/or to teach thinking skills.

Students will be provided with opportunities to develop skills in selecting and organizing information in order to think clearly, to reason logically, to examine different points of view, and to reach sound conclusions.

Information regarding controversial issues will:

- Represent alternative points of view subject to the condition that resources used are not restricted by any federal or provincial law;
- Appropriately reflect the maturity, capabilities and educational needs of the students;
- Reflect the requirements of the course of study as stated in the Programs of Study;
 and
- Reflect the neighbourhood and community in which the school is located, as well as provincial, national and international contexts.

Students will be provided with the opportunity to explore controversial issues in an intellectually and emotionally safe environment.

Sensitivity on the part of teachers, students and other participants in controversial issue discussions will be exercised to ensure that students and others are not ridiculed, embarrassed, intimidated or degraded for positions which they hold.

The treatment of controversial issues in the classroom must take place within the framework of a set of rules established by the Education Act (Section 58), Education Amendment Act (Bill 27) and Thrive Charter School.

The legislation requires the following:

- Provide parents with notice where courses and instruction include subject matter that deals primarily with and explicitly with religion, religious themes, human sexuality and sexual orientation.
- This notice is provided in writing, and may be contained in course registration, course outlines, course descriptions or direct written communication to parents.
- Instruction or materials that include content related to sexual orientation, gender identity, or human sexuality shall be delivered only to students whose parents/guardians have provided written opt-in consent at least 30 calendar days prior to the instruction.
- Teachers and school administrators must submit all external teaching materials and third-party presenter content related to these topics to the Superintendent for approval, who will then seek Ministerial approval in accordance with Bill 27.

The Education Act requires teachers and school administrators to exercise their professional judgment to determine when notice is to be provided to parents and to handle complaints or concerns raised by parents.

Materials such as course outlines or student handbooks that identify potential controversial issues will include a section that identifies the parent's right to exclude their child from that portion of the program.

If parent request for exclusion of the child from a part of the program is denied, the parent has the right to follow the appeal process identified in Administrative Procedure 390 – Appeals Concerning Student Matters.

A reason will be provided to the parent defining why the request was denied by the teacher or Principal.

The Principal will ensure that a school procedure is developed regarding:

- Identification and notification of controversial issues.
- The input of students, parents, teachers and administrators in developing procedures related to the controversial issues to be studied.
- The requirement that teachers make provisions for alternative activities for students who choose not to participate.
- The approval of the teacher's course outline and plan by the principal regarding the objectives, the resources and the teaching strategies.

Where a parent makes a written request, teachers will exempt the student, without
academic penalty, from such instruction, course of study, educational program or
use of instructional material. These requirements do not apply to incidental or
indirect references to religion, religious themes, human sexuality or sexual
orientation.

The expectation that teachers are to continue to respectfully handle the decisions and perspectives of parents when providing instruction and choosing instructional materials.

The requirement that the procedure will include a section on retention of notice to exempt from parents.

Requests for exemption will be included in the Student Record and will not be expunged for three (3) years.

It is the teacher's responsibility to fully understand the content of their courses and identify potential controversial issues. If the teacher is unsure, they should discuss the matter with the principal.

Notification

Instruction or materials that include content related to sexual orientation, gender identity, or human sexuality shall be delivered only to students whose parents/guardians have provided written opt-in consent at least 30 calendar days prior to the instruction.

Parents may provide whole or partial consent to their child receiving instruction and or materials related to this topic.

Teachers and school administrators must submit all external teaching materials and third-party presenter content related to these topics to the Superintendent for approval, who will then seek Ministerial approval in accordance with Bill 27.

The Principal will annually review the Alberta Education Guide to Education for information pertaining to notification of parents of controversial issues.

A written notice must be provided to the parent indicating that a particular outcome or component of a course contains subject matter that deals primarily and explicitly with religion, human sexuality or sexual orientation.

In the circumstance where a student is registered for a specific course that deals primarily and explicitly with religion, religious themes, sexual orientation or human sexuality, notice may be given by advising the parent on the registration form for said

course identifying that the course is primarily and explicitly about religion, religious themes, sexual orientation or human sexuality, rather than providing notice for each controversial learning outcome. A parent so notified may give notice of their request for exemption at the time of registration.
